Based on a loan of £155,000 for 25 years, on the standard variable rate of 5.10% for the term of the mortgage the total amount payable would be £276,697.66 made up of the loan amount plus interest repayable by 1 monthly instalment of £936.83 followed by 299 monthly instalments of £915.17.
